## GOREY CREDIT UNION CAR DRAW RULES:

- 1. The Draw will commence when sufficient members participate and will continue at intervals as determined by the Board of Directors. Initially, the frequency of the draws will be determined by the prize fund on hands.**
- 2. Provisional first draw date: June 2007 or sooner should funds allow.**
- 3. In the event that insufficient members subscribe to the draw, it may be suspended, amended or discontinued at the discretion of the Board of Directors.**
- 4. The subscription fee will be €5 per month, commencing on 01st February 2007 and on the 1st of every month thereafter. This fee will be deducted from member's shares. Date of joining the draw will determine initial entry.**
- 5. It is the member's responsibility to ensure that sufficient funds are in place at the relevant time to enable their entry to be included. The Credit Union has no obligation to notify members with insufficient funds in their accounts.**
- 6. Entry is limited to one person per account.**
- 7. Participation in the draw is limited to eligible members of Gorey Credit Union who are 18 years of age or over on or before the draw date.**
